1. Applications in prescribed proforma are invited from the intending eligible applicants to apply for the post of Attendant, Laboratory Attendant and Peon (Group- D) for engagement on contractual basis in the Offices of the Dean & Principal/ Superintendent, Saheed Laxman Nayak Medical College and Hospital, Koraput. The different category-wise vacant posts are as detailed below.

2. RESERVATION:

- (i) Person with disabilities (PWD)-4% (Which comes one from V.I.(LV) Category.
- (ii) Ex- Serviceman-3%
- (iii) Sportsman-1%

Candidates belong to PWD, Ex- Serviceman and Sports person shall be adjusted against the categories to which they belong. In case of non-availability of eligible /suitable women candidate belonging to respective category, the unfilled vacancies of that category shall be filled up by the eligible suitable male candidate(s) belonging to the respective category.

3. AGE:

A candidate must have attained the age of 21 (Twenty-one) years and must not be above the age of 32(Thirty-two) years on 1st day of May 2020. The upper age limit is however relaxed by 5 years in respect of ST/SC/SEBC/ Women candidate(s) and 10 years in case of person(s) with disability and in case of Ex- Serviceman candidate(s) as per prevailing rules. A person, who comes under more than one reserved category, shall be eligible for availing only one benefit of relaxation which shall be considered most beneficial to his/her.

Provided further that, the Attendants engaged on contractual basis under the Scheme/Project under H & FW deptt. who are below the age of 45 years and have completed one year of continuous service shall be allowed to take part in the recruitment process as per H& FW Department Letter No. 26288 dated 14.12.2016. They shall also be allowed 1% (One Percent) extra marks of the total marks for each completed year of continuous service subject to maximum 15% (Fifteen Percent) which will be added to the marks secured by them for deciding their merit position.

4. EDUCATIONAL QUALIFICATION:

Candidate shall have passed M.E. (07th) Examination or equivalent and can read, write & speak Odia. The selection shall be made on the basis of marks secured in 07th pass certificate. The 07th pass certificate must be verified by Block Education Officer and then be countersigned by the concern District Education Officer prior to issue of appointment orders.

5. MODE OF SELECTION:

- (a) One selection Committee has been constituted at the level of this Office of the Dean & Principal, SLN Medical College and Hospital, Koraput.
 - (b) There shall be no Written Test or Interview.
 - (c) The selection shall be on the basis of merit list prepared by taking into consideration of the marks secured in Class- VII pass certificate and will be valid for a period of one year or till completion of panel list within one year whichever is earlier.
 - (d) For any clarification, the decision of Govt. in Health & Family Welfare Department shall be final.

If any candidate is found to have suppressed any material fact, information or furnished false information, documents, his/her case shall not be considered for the post applied for and in case already engaged on the basis of the said information /documents his/her service shall be terminated forthwith. Candidates who have been disengaged previously on administrative ground such as disobedience/poor performance/misbehavior/ criminal activities etc. are not eligible to apply for the aforesaid posts. A candidate found guilty of seeking support for his/her candidature by offering illegal gratification or putting pressure on any authority concerned for selection of post will be disqualified for selection and action shall be taken as per law.

6. OTHER ELIGIBILITY CRITERIA:

- a. Candidate must be a citizen of India.
- b. Candidate must be a permanent resident of Koraput District.
- c. Candidate must not have more than one spouse living.
- d. Candidate must be of good character and good mental condition.
- e. Candidate must be sound health, good physique and free from organic defects or bodily infirmity.
- f. Appointment is purely on contractual basis and may be terminated at any time without asking any reason thereof.
- g. The selected candidates will have to undertake that they will not claim any financial benefits other than the monthly remuneration which they will receive.
- h. Candidate appointed on contractual basis will not claim for inter Medical College /Hospital transfer.
- i. Any legal dispute is subject to be jurisdiction of Court(s) situated in Odisha.
 - j. Candidate must have registered his/her name in the Employment Exchange Office of Koraput District.
 - k. Must be able to speak, read & write Odia fluently & must have passed either the Middle School Examination with Odia as Language Subject or equivalent examination with Odia as a subject.
 - l. Minimum age is 21 years and of must not above the age of 32 years as on 01.05.2020.

- f. One self addressed envelope(24x10) cm duly stamped with Rs. 41/-

g. Self attested copy of the Certificate in support of passing Odia as a language subject.

h. NOC from present Employer (in case of in service candidates).

i. Original Service Certificate and Performance Certificate issued by the present Employer (in case of in service candidates).

j. Disability Certificate (including percentage of permanent disability issued by the concerned Medical Board of the concerned District wherever applicable.

k. OBC Certificate will not be accepted in lieu of SEBC Certificate.

 The candidates shall have to furnish a copy of the Valid Employment Exchange Registration Card to the effect that his/her name has registered in the Employment Exchange Office of Koraput District.

m. Xerox copy of Photo ID issued by State/Central Government.

n. An affidavit from Notary Public stating that No Criminal or Civil Cases pending against him/her.

8. REMUNERATION:

All contractual Attendants, Laboratory Attendants and Peons will be paid the consolidated monthly remuneration of Rs.8,070/- per month in pursuance to G.A. & P.G. Department Notification No. 28090/F, dated 22.09.2017.
