Selection Procedure for Technician (1):

The candidates recommended by the Screening Committee will be called for Trade Test. The Trade test will be qualifying in nature and only those candidates who qualify in the Trade Test shall be called for the Competitive Written Examination.

Mode of selection:

- A. Trade Test: SSC + ITI/ XII th Standard Level based on the advertised qualification of the post.
- B. Competitive Written Examination: Objective Type Multiple Choice Examination (English/Hindi), Total Questions 150, Total Time allotted 2 Hours 30 Minutes.

^{*}The PAPER-I (Mental Ability Test) will include General Intelligence, Quantitative Aptitude, Reasoning, Problem Solving, Situational Judgment etc. The PAPER-II & PAPER-III will be evaluated only for those candidates who secure the minimum threshold marks in the PAPER-I. The Final merit list will be prepared only on the basis of the marks obtained by the candidates in Paper-III & Paper-III.

General information and conditions:-

1. Benefits under Council service:

a. These posts carry usual allowances i.e. Dearness Allowance (DA), House Rent Allowance (HRA), Transport Allowance (TA) etc. as admissible to the central government employees and as made applicable to CSIR. Council employees are also

eligible for accommodation of their entitled type as per CSIR Residence allotment rules depending on availability in which case HRA will not be admissible.

- b. In addition to the emoluments indicated against each category of posts, benefits such as applicability of New Pension Scheme 2004, reimbursements of Medical Expenses, Leave Travel Concession, Conveyance advance and House Building Advance are available as per 7th CPC & CSIR rules.
- c. The appointees are liable to be posted in any of the Laboratories/ Institutes of CSIR situated in other parts of India as and when need arises.
- d. CSIR provides excellent opportunities to deserving candidates for career advancement under assessment promotion scheme for technical staff.

2. Other Conditions

- The applicant must be a citizen of India.
- b. All applicants must fulfil the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for various posts as on the last date of receipt of the applications. No enquiry asking for advice as to eligibility will be entertained. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for Trade Test & Competitive written examination. The duty constituted Screening Committee will adopt its own criteria for short-listing the candidates. The candidate should therefore, mention in the application all the qualifications and experiences in the relevant area over and above the minimum prescribed qualification, supported with documents.
- c. Applications from employees of Government Departments, Autonomous bodies, Public Sector Undertakings, etc will be considered only if forwarded through proper channel, certified by the employer that the applicant, if selected will be relieved within one month of the receipt of the appointment orders. Also, vigilance clearance should also be recorded in such cases. However, advance copy of the application may be submitted before the closing date. Applications routed through proper channel should reach CSIR-NEIST, Jorhat at the earliest.
- d. The duly filled application in the prescribed format should be accompanied by self attested copies of the relevant educational qualification, category, experience etc. The prescribed qualifications should have been obtained through recognized universities / Institutions etc. Incomplete applications/applications received or not accompanied with the required certificates/documents are liable to be rejected.
- e. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the Application is liable to be rejected. The decision of CSIR with regard to equivalence of qualification(s) and about recognition of Universities/ Institutes shall be final and binding.
- f. The period of experience rendered by a candidate on part time basis, daily wages, visiting/guest faculty will not be counted while calculating the valid experience for short listing the candidates for trade test/ written test(as applicable).
- g. If any document/Certificate furnished is in a language other than Hindi or English, a transcript of the same duly attested by a Gazetted Officer or notary is to be submitted.
- h. The date for determining the upper age limit, qualifications and / or experience shall be the closing date prescribed for submission of applications i.e.01.01.2021.
- i. The period of experience in a discipline / area of work, wherever prescribed, should be in relevant area of work/field indicated against such posts and shall be counted after the date of acquiring the minimum prescribed educational qualifications prescribed for that post.
- j. Persons with disabilities (PWD) fulfilling the eligibility conditions prescribed under GOI instructions are encouraged to apply.
- k. Reservation for Economically Weaker Sections (EWS) is applicable as per GOI instructions.
- I. Reservation for Ex-Servicemen is applicable as per GOI instructions.
- m. Any discrepancy found between the information given in application and as evident in original documents will make the candidate ineligible for appearing in trade test/ written test. No TA will be reimbursed for Trade Test/ Written Examination.
- n. The decision of the CSIR-NEIST, Jorhat in all matters relating to eligibility, acceptance or rejection of application, mode of selection, and conduct of examination/trade test will be final and binding on the candidates.
- o. Canvassing in any form and/ or bringing any influence political or otherwise will be treated as a disqualification for the post.
- p. The Director, CSIR-NEIST reserves the right to cancel the advertisement without assigning any reason thereof.
- q. Notifications regarding dates for Trade Test & Written Examination shall be displayed on the Institute's website: www.neist.res.in.

r. No interim enquiry or correspondence will be entertained.

3. Relaxation:

- a. The upper age limit is relaxable upto 05(five) years for SC/ST and 03(three) years for OBC as per Government orders in force only in those cases where the posts are reserved for respective categories, on production of relevant certificate in the format prescribed by Govt. of India signed by the appropriate competent authority at the time of Trade test/Written examination. It may please be noted that the appointments to the reserved posts will be provisional and subject to the verification of caste certificates through proper channel.
- b. Upper age limit for persons with disabilities shall be relaxable by
 - i. 10 Years relaxation is allowed. (15 years for SC/ST candidates and 13 years for OBC candidates).
 - ii. Relaxation in age limit shall be applicable irrespective of the fact whether the post is reserved or not, provided the post is identified suitable for persons with disabilities.
 - iii. The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for each individual posts to be filled by Direct Recruitment by Selection.
- c. Upper age limit is also relaxable upto five years for the regular employees working in CSIR Laboratories/Institutes, Government Departments, Autonomous Bodies and Public Sector Undertakings. This concession is admissible to such Govt. servants who have rendered not less than three years continuous service and are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of the posts, recruitment to which has been advertised.
- d. Age relaxation shall also be applicable to the following categories of candidates as per the Government of India rules and instructions as made applicable to the council servants from time to time:
 - i. Persons who had ordinarily been domiciled in the Kashmir division of the state of Jammu and Kashmir during the period from 1-1-1980 to 31-12-1989.
 - ii. Defence Services personnel disabled in operations during hostilities with any foreign country or in a disturbed area and released as a consequence thereof, Ex-Servicemen including Commissioned Officers and ECOs/SSCOs.
- e. As per GOI provisions, age relaxation for Widows, Divorced Women and Women Judicially separated from Husbands, who are not remarried, the upper age limit is relaxable up to the age of 35 years (upto 40 years for members of Scheduled Castes/Scheduled Tribes and upto 38 years for members belonging to the Other Backward Classes in respect of the posts reserved for them). The persons claiming age relaxation under this sub-para would be required to produce following documentary evidence:
 - i. In case of Widow, Death Certificate of her husband together with the Affidavit that she has not remarried since.
 - ii. In case of divorced Women and Women judicially separated from their husbands, a certified copy of the judgment/ decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an Affidavit in respect of divorced Women and they have not remarried since.

4. How to apply:

- a. Eligible candidates are required to fill up the application form in the prescribed format. No other mode of application will be considered.
- b. Candidates are advised to go through the general instructions carefully before applying.
- c. Candidates are required to arrange for a crossed **Demand Draft for Rs.100/ drawn on any nationalized bank and valid for at least 3 months in favour of "Director, CSIR-NEIST, Jorhat" payable at Jorhat.** The following details must be filled up on back side of Demand Draft (i) Candidate's Name, (ii) Candidate's Category, (iii) Post Code Applied. The Candidates belonging to SC/ST/PWD/Women/CSIR Employees/Abroad category are exempted from payment of application fee.
- d. This duly signed and filled up application accompanied by self attested copies of the certificates, mark sheets, testimonials in support of age, education qualifications, experience, re-prints of publications and caste certificate, if applicable along with one recent passport size (self-signed photograph) affixed together with Demand Draft (if applicable) should be sent in an envelope super scribed "APPLICATION FOR THE POST OF_________(Post Code _______)"by post to the address:

- e. Candidates applying for more than one post must submit separate application form for each post indicating the Code No. of the post. The hard copy(s) of each application must be accompanied by separate Demand Draft(s) and each application must be accompanied by self attested copies of the relevant educational qualification, mark sheets, certificates in support of age, category, experience, caste etc wherever applicable.
- f. Only a single application will be entertained from each applicant for each post code and in case an applicant submits multiple applications for the same post code, only the latest completed application for which the hard copy is submitted will be considered.
- g. Application once made will not be allowed to be withdrawn and fees once paid will not be refunded on any count nor can it be held in reserve for any other recruitment or selection process.
- h. Candidates should specifically note that the applications received after the closing date for any reason whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by CSIR-NEIST, Jorhat.
