- Scale of Pay & conditions of Service-The appointment to this post will be initially on contractual basis carrying a remuneration of Rs. 16880/- per month(for 1<sup>st</sup> year) as per Govt. in G.A. & P.G. Department Notification No. 19569/G.A. dated 12.09.2017 and Condition of Service will be guided by (Contractual Appointment) Rules, 2013 & Food Safety Standard Rules-2011.

## ELIGIBILITY

- i) Age:-Must not be below 21 years and above 32 years of age as on 1.1.2020 with usual age relaxation as per rules for SC,ST,SEBC,Women,,Ex-servicemen & In-service contractual employees.
- ii) Minimum Educational Qualification- (a) The candidate applying for the post must have passed Bachelors Degree/Graduation from any recognised University.
- (b) Besides the candidate to possess adequate knowledge in computer application i.e windows, MS office (Word, Excel & power point), MS Access & Usage of Internet services.

## PLAN OF EXAMINATION:-

**Preliminary Examination- 100** marks (Objective type) (0.25 negative mark per each wrong answer). Candidates 20 times of the vacancies shall be short listed for Physical Test.

Physical Test: - The candidates who qualify in the Physical test shall be allowed to appear Main written examination.

Main Written Examination: - Paper-I General English (Subjective type) -50 marks

Paper-II Odia Language (Subjective type)-50 Marks.

Paper-III General Studies (Objective Type) 200 marks ( 200 nos of questions .0.5 negative marks per each wrong answer)

Paper-IV Computer (Skill) Test (Objective type) 50 Marks (Qualifying only)

Candidates three times of vacancies in order of merit category wise basing on the marks secured in Written Examination shall be shortlisted for Viva- Voce-Cum- Psychological test.

Computer Skill Test (CST)-50 marks-qualifying only (Qualifying mark-17),

Select List-The Select List shall be prepared in order of merit category wise basing on the marks secured in the Main Written Exam and Viva- Voce- Cum- Psychological Test.
