Evaluation criteria for short listing and final selection of the candidates

1. Eligibility Criteria:

a. Nationality: The candidate must be a citizen of India.

- **b.** Age Limit: Lower and upper age limits will be 21 years and 35 years (for men) / 40 years (for women) respectively, with relaxation of age to SC/ST/OBC and Divyaang candidates as per rules.
- c. Essential Educational Qualifications: Essential: M.Sc in Zoology/Bioinformatics)

***** Essential Educational Qualification : 60 marks

- Candidates having <u>first class/first division</u> (based on percentage/Grade points) in 10th, 10+2, Graduation and Post-graduation will get <u>15 marks each in the respective category</u>. (Ex. Candidate having first class/first division in 10th, 12th, Graduation and Post-graduation will get 15+15+15=60 marks)
- Candidates having <u>second class / second division</u> (based on percentage/Grade points) in 10th, 10+2, Graduation and Post-graduation will get 10<u>marks each in the respective category</u> (Ex. Candidate having <u>second class/second division</u> in 10th, 12th, Graduation and Post-graduation will get 10+10+10+10 = 40 marks)
- Candidates having <u>pass /third division</u> (based on percentage/Grade points) in 10th, 10+2, Graduation and Post-graduation will get 3 <u>marks each in the respective category</u> (Ex. Candidate having <u>pass /third division</u> in 10th, 12th, Graduation and Post-graduation will get 5+5+5+5 = 20 marks)

3. Personal Interview : 40 marks

- 1. Only 10 numbers of candidates who stand sufficiently high in merit on the basis of aggregate marks obtained in respect of essential educational qualifications criteria as mentioned under Column I to IV of the Score card table given under para 2 above. For short listing the candidates for calling to attend the interview, a merit list of all candidates fulfilling the essential eligibility criteria as mentioned under para 1(a), 1(b) and 1(c) above will be prepared and top 10 numbers of candidates in the merit list will be shortlisted. If any or few or all of the first 10 numbers of shortlisted candidates express his / her unwillingness / disinterest to attend the interview, the candidates in required number positioned at Sl. No. 11 onwards in the said merit list may be given opportunity to attend the interview.
- 2. Final selection will be on the basis of candidate's performance in the short listing and interview taken together in order of merit.

Tie-breaking Principles

A. For short listing the candidates for interview:

a) In a case where the total marks obtained in r/o column No. I to IV are equal, the candidate senior in age will be ranked higher.

B. For final selection of the candidates:

a) In a case of the overall equal marks, the candidate senior in age will be ranked higher.

INSTRUCTIONS FOR APPLYING (ONLINE)

The following steps are to be followed for applying online and submitting supporting documents:

- 1. The applicant will visit institute website <u>http://www.cifa.nic.in</u> and visit the "**Job Opportunities**" tab under **Quick Links Section** for finding the link for submission of the applications.
- 2. In the said online form, candidates need to fill all the column with accurate information and submit the same.
- 3. After doing the needful as S.No. 2 above, the applicant will have to scan the following documents in given order in a single "pdf" format file:
- a. Duly filled and signed application format as given in Annexure-III
- b. Matriculation certificate & marks sheet
- c. Intermediate mark sheet
- d. Graduation mark sheet
- e. Caste/ Category certificate in case of SC/ ST/ OBC & Divyaang applicants
- f. Any valid Photo Identity proof document (Aadhar Card/ Voter Id/ Pan Card/ Driving Licence, etc. issued by any government agency). Aadhar Card will be preferred.
- g. Any other relevant document as desired by the applicant.
