1. In view of Notification No.35164 dated 29.10.2020 of Government of Odisha Home Department and Letter No.1309 dated 02.02.2021 of the Hon'ble High Courts of Orissa (SOP) and Letter No.2691(21) dated 01.03.2021 of the Hon'ble High Courts of Orissa, applications in prescribed format are invited from the eligible retired ministerial staffs and group-D employees for their appointments as per the scheme of the Odisha Fast Track Special Courts (Method of Recruitment and conditions of Services of retired Judicial Officers of the Cadre of District Judges and Staff including in-service Judicial Officers in the regular cadre of District Judge, Ministerial Staff and Group-D employees Scheme-2020) on adhoc basis for their reengagements for the post of Bench Clerk Grade-I, Stenographer Grade-I, Senior Clerk, Senior Typist, Junior Clerk(computer knowing) and peon/orderly(group-D) on adhoc or temporary/contractual basis under the above scheme of 2020.

3. Eligibility Conditions:-

- a) The Ministerial Staff and Peon who have retired from service on attaining the age of superannuation or on voluntary retirement having a clean service record shall only be eligible to be considered for such appointment subject to fitness and suitability;
- b) The retired Ministerial Staff and Group-D employees must not be above the age of 70 years as on the date of advertisement;
- c) The retired Ministerial Staff and Group-D employees, who have been dismissed, removed, compulsorily retired from service or had sought voluntary retirement after initiation of Departmental Enquiry against them shall not be eligible to be considered for such ad-hoc appointment.

4. Pay and other Allowance:-

A retired Ministerial Staff or Group-D employee on appointment under the Scheme on Ad-hoc basis shall be entitled to receive pay and allowances at the rate

he/she was drawing at the time of retirement minus total amount of pension being received by him/her after commutation under the Pension Rules applicable to him/her. He/ She shall also be entitled to all other regular allowances admissible to in-service staff of the respective cadres.

On being appointed into service, under the scheme, an in-service ministerial staff or Group-D employee shall be eligible to get the pay and allowances as is applicable to the employees of regular cadre/class, to which he/she belongs.

5. Attendance & Leave:-

- a) The Ministerial Staff and Group-D employee appointed on ad-hoc basis under the Scheme shall be entitled to 10 days Casual Leave and 5 Days Special Casual Leave in a calendar year;
- b) They are not entitled to any other kind of leave during the period of appointment;
- c) Proportionate reduction of pay and allowances shall be made for unauthorized absence, so also for absence beyond permissible period of leave.
