## 2. ELIGIBILITY OF THE CANDIDATE:

The retired judicial Ministerial Staff and Peon who have **retired from service** on attaining the age of superannuation or on voluntary retirement having a **clean service record** shall only be eligible to be considered for such appointment subject to **fitness and suitability**,

Provided he/she must not be above the age of 70 years as on the date of Advertisement.

Provided he/she must not be dismissed, removed, compulsorily retired from service had sought voluntary retirement after initiation of departmental enquiry against him/her.

# 3. PAY AND OTHER ALLOWANCES:-

A retired Ministerial Staff or Group-D employee on appointment under the Scheme on Adhoc basis shall be entitled to receive pay and allowances at the rate he/she was drawing at the time of retirement minus total amount of pension being received by him/her after commutation under the Pension Rules applicable to him/her.

# 4. TERMS AND CONDITIONS OF APPOINTMENT:-

- i) The appointment of Ministerial Staff and Group-D employees made under the scheme shall be purely on contractual basis,
