- 2. The original certificates and proof of age and caste to be produced at the time of interview/Joining.
- 3. The selected candidate may also be required to travel, as per requirement of the work.
- 4. No TA/DA will be paid for attending the interview.
- 5. No interim enquiries will be entertained. Canvassing in any form will render the candidate disqualified for the position.

- 6. The above engagements are purely temporary and will stand terminated automatically after completion of period indicated in the selection offer, or otherwise intimated subsequently subject to willingness of the candidate.
- 7. The candidate will not have any right for absorption in ICAR-CIFA/ICAR.
- 8. The selected candidate may have to join immediately.

❖ Essential Educational Qualification : 45 marks

- Candidates having <u>first class/first division</u> (based on percentage/Grade points) in 10th, 10+2 and Graduation (Bachelor's Degree) will get <u>15 marks each in the respective category</u>. (Ex. Candidate having first class/first division in 10th, 12th and Graduation (Bachelor's degree) will get 15+15+15 = 45 marks)
- Candidates having <u>second class / second division</u> (based on percentage/Grade points) in 10th, 10+2 and Graduation (Bachelor's Degree) will get 10 <u>marks each in the respective category</u> (Ex. Candidate having <u>second class / second division</u> in 10th, 12th and Graduation (Bachelor) will get 10+10+10 = 30 marks)
- Candidates having <u>pass /third division</u> (based on percentage/Grade points) in 10th, 10+2, and Graduation (Bachelor's Degree) will get 5 <u>marks each in the respective category</u> (Ex. Candidate having <u>pass /third division</u> in 10th, 12th and Graduation will get 5+5+5 = 15 marks)

<u>Note</u>: Candidates having only the CGPA/OGPA in their mark-sheet /transcript, the conversion formula of CGPA/OGPA to percentage of marks or division as adopted by the University /Board needs to be enclosed with the respective transcript/mark sheet, or else the decision in this regard made by the competent authority of the ICAR-CIFA will be treated as final.

Desirable Qualifications : 20 marks

Experience in laboratory techniques/instruments handling/ fish breeding and management/ reproductive techniques etc.

- i. Candidates having 6 months to 1-year research experience will be awarded 5 marks. (Experience less than 6 months will not be counted for allotting marks)
- ii. Candidates having >1 year and up to 2 year of research experience will be awarded 10 marks
- Candidates having >2 year and up to 3 year of research experience will be awarded 15 marks
- iv. Working experience of more than 3 years of research experience will be awarded 20 marks

❖ Personal Interview : 35 marks

Note:

- Only 10 numbers of candidates will be called for interview for the selection of 1 (One) Project
 assistant (PA) that stand sufficiently high in merit on the basis of aggregate marks obtained in
 respect of educational and desirable qualifications criteria as mentioned under <u>Column I to IV</u> of
 the Score card.
- 2. Final selection will be on the basis of candidate's performance in the shortlisting and interview taken together in order of merit.

Tie-breaking Principles

A. For shortlisting the candidates for interview:

- a) In a case where the total marks obtained in r/o column No. I to IV are equal, the candidate senior in age will be ranked higher.
- b) Further, if the candidates are of same age, the candidate securing more total marks in r/o column No. III and IV will be ranked higher.

B. For final selection of the candidates:

- a) In a case of the overall equal marks, the candidate senior in age will be ranked higher.
- b) Further, if the candidates are of same age, the candidate who has obtained higher marks in r/o column No. IV while short listing the candidates, will be ranked higher.

- i. Any other relevant document as desired by the applicant.
