In pursuance of letter No. – 1322 / SSD Dt. 20.01.2020, letter No. – 7924 / SSD Dt. 09.06.2020 and subsequent letter No. – 16163 / SSD Dt. 18.11.2020 of Govt. in ST & SC Dev. Deptt., Odisha, applications in prescribed form are invited from the deserving candidates from native of Sundargarh District for engagement as Tribal Language Teachers functioning under the ST & SC Dev. Deptt. schools of Sundargarh District.

The candidates applied earlier as per this office Notification No. – 489 / SSD Dt. 12.02.2020 need not apply 2nd time as their candidature will also be taken into consideration in the Final Scrutiny and Selection.

1. Qualification. :

ST candidates (of the same tribal community for which language the selection is being made) having minimum qualification of +2 Science / Arts / Commerce or its equivalent examination declared by the appropriate authority with desirable training qualification and the candidate must have proficiency in the Language which is operational in schools under MLE programme. The candidate must have Odia as mother tongue language up to Class- VII.

2. Age. :

The Candidate shall not be 18 years and above 40 years at the time of submission of application.

3. RESERVATION. :

As per principle of reservation aspect under the guidelines for engagement of Tribal Language Teachers, the reservation shall be substituted with the following manner. : “ Not withstanding any thing contained in the Guidelines, reservation of vacancies for SC/ST/SEBC/Sportsman/ Physical Handicapped / Ex – Serviceman / women shall be provided under the Odisha Reservation of vacancies in posts and service (for scheduled Castes /Scheduled Tribes) Act, 1975 and the rules framed thereunder and under such other rules and orders issued by the Government from time to time.”

Provided further that if any other reserve category except ST are not available then the posts shall be filled up by the ST category of the said community.”

4. Selection Procedure. :

The Selection shall be made only on merit basis i.e. There shall be a “Proficiency test” for the concerned tribal language to be conducted at the concerned District HQ. The proficiency test paper will be set by Director SCSTRTI with the assistance of subject matter specialists. The test question papers will be provided to the concerned districts in sealed covers and will be taken back after the examination in sealed covers for evaluation at SCSTRTI by the subject matter specialists. There will be 75.25 weightage given to each candidate for the concerned language proficiency (marks obtained in the proficiency test) and percentage of marks secured by the candidate in the qualification examination (HSC). The selection of the MLE teachers will be on merit basis thus decided.

- (k) In case of two or more candidates secured the same marks the candidate older in age will be placed above in the rank.
- (ii) Higher Education will not be given any weightage during preparation of merit list in all categories.

5. Remuneration. :

The monthly consolidated remuneration of the persons to be engaged in the contractual post of Tribal Language Teacher is Rs. 9,250 /-. Every year their remuneration shall be hiked as per GA Deptt. Notification No. – 19574 / Dt. 12.09.2017.

6. Service Conditions. :

- i. The service of MLE Teachers is purely temporary and contractual in nature. The service is terminable without notice by the competent authority without assigning any reason thereof.
- ii. A contract / agreement shall be executed between the Collector on behalf of the State Govt. and by the contract person to be signed on stamp paper.
- iii. The contract will be valid up to the end of February of the financial year from the date of engagement and can be terminated earlier if he / she violates the conditions of contract or is found unsuitable by the authority without assignment any reason.
- iv. While making contract engagement the engagement order must make it very clear that the engagement is valid up to the end of February of the financial year and renewal of the contract engagement can be considered only if the continuance of the post is extended with concurrence of the FD and subject to satisfactory performance of the candidate to be evaluated by the appropriate authority shall ensure a written undertaking from the contractual appointees in the model form.
- v. The contract person shall be entitled to avail leave under the provisions of the Odisha leave Rules 1966 at par with regular employees of Govt. Odisha.
- vi. The MLE Teacher must maintain regularly and punctuality in attending school. They must impart teaching in their respective languages along with other languages. They must ensure completion of entire curriculum within the specified time. They must assess the learning ability of each child and accordingly supplement additional instructions if any as required. They must ensure minimum level of learning for the students as prescribed by the competent authority. They must ensure at least 90% attendance of the children in respective schools in all classes. They shall motivate the parents / guardians of the village in which school is situated for enrollment of children within the age group of 6 – 14 years. They shall perform all such other duties as assigned to them by Competent Authority as and when required.
