The final merit list shall be prepared for all candidates, who appeared for the interview by compiling marks secured in all the two stages.

- If two candidates secure equal marks. Then the merit list shall be so prepared that, candidate higher in age shall be placed higher in the merit from amongst those candidate only.
- Calculation of marks in case of graduation will be made on the basis of marks secured by the candidates in aggregate.
- The assessment of career marks shall be up to 3(three) digits, for example -50.567%
- Waiting list to be maintained and should be valid for 1(one) year from the date of approval of the panel of selected candidates.
