- b) Must have passed at least Diploma in Computer Application from a recognized institute.
- c) Be over 18 years and below 32 years of age on the last date fixed for receipt of application (Provided that the upper age limit in respect of reserved categories of candidates shall be relaxed in

accordance with the provisions of the relevant act, rules, orders or instructions for the time being in force.

- d) The candidate shall possess minimum speed of 80 words in Shorthand and 40 words in Typewriting per minute.
- e) Be able to speak, read and write Oriya and have passed a test in Oriya equivalent to the M.E. standard.
- f) Having good character.
- g) Having sound health, free from organic defects or bodily infirmity and;
- h) Have not more than one spouse living, if married.

#### Fees for Examination:

The candidates are required to deposit fees of Rs. 100/-( one hundred) only in shape of Treasury Challan under the Head "0070other administrative services-01-administration of Justice-501services and service fees--9904650-Law Department-0916730examination fees for recruitment conducted by Orissa District & Subordinate Courts" and to submit the original copy of challan along with their application forms.
