The selection of Jogana Sahayak will be made per the instruction communicated vide letter No 7040 / dt.21.04.2012, letter No7443/ dt. 27.04.2012,letter No. 13723 /dt.12.08.2013,letter No. 21547 /dt. 20.12.2013 ,letter No. 6112 /dt. 27.03.2018 of Govt. of Odisha in F.S & C.W Dept. - The candidates should be a permanent resident of the concerned G.P
- 1 Minimum qualification of Jogan Sahayak is 10th pass (equivalent to matriculation)
 - 2 Weightage on career making of 10th pass/+2pass/+3 pass will be given
 - 3 He / She should be of age between 21 to 35 years as on 31.10.2021.

The Selection will be based on the career marking in 10th pass/matriculation (30% weightage), +2 (30% weightage), +3 (40% weightage) examination.




