Applications invited for Contractual Engagement for Gram Rozgar Sevak (GRS)

Applications are invited from eligible candidates of Cuttack District through online mode for filling up vacant post of Gram Rozgar Sevak (GRS) to be engaged in different Gram Panchayat under MGNREGS for Cuttack District on contractual basis for a period of 1 year. The newly recruited GRS will get a consolidated monthly remuneration of Rs. 7,000/- (Rupees seven thousand) only and after successfully worked for more than 1 year and less than 6 years will get Rs. 8,500/- per month and after successfully worked for more than 6 years will get Rs. 8,880/- per month which may be revised with approval of Government.

Vacancy Position:

The vacancy for the post of 111 nos. of Gram Rozgar Sevaks (GRSs) as per the category wise reservation mentioned below are to be filled up following the provisions contained in Orissa Reservation of Vacancies in Post & Services (for Scheduled Caste & Scheduled Tribe) Act, 1975 and Rules formulated there under. The number of vacancies along with category as well as Gender as mentioned below may be increased or decreased, subject to the position to be arrived at the time of selection, and subsequent vacancy thereof.

Out of the above total vacancies:

- 1. 4% of the post shall be reserved for PwD candidates for the following benchmark disabilities.
 - c) 2% reservation for deaf and hard of hearing.
 - d) 2% reservation for locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.

Out of the above, 1% reservation shall be earmarked for women with disability.

- 2. 1% of the post shall be reserved for Sports Person candidate.
- 3. 3% of the post shall be reserved for Ex-Serviceman candidate.

Further, the reservation in respect of the special categories like, Sports person (1% of the vacancies), Ex-Servicemen (3% of the vacancies) & Person with Disabilities (4% of the vacancies) shall be adjusted against the categories to which they belong.

The advertisement for Contractual engagement of Gram Rozgar Sevak (GRS) under MGNREGS in Cuttack District made vide DRDA Advertisement No. 4419 dt. 23.10.2018 and published in daily The Samaj, The Sambad & The Indian Express & web hoisted in the Cuttack district website on dt. 01.11.2018 was cancelled vide order no. 3759 dt.20.12.2021. The candidates who had applied earlier as per this Office Advt.no. 4419 dt. 23.10.2018 may also apply afresh as per the criteria mentioned in the current Advertisement.

ELIGIBILITY CRITERIA:

- 1. Age: Age of the applicant shall not be below 18 years and shall not exceed 40 years as on 1st January, 2022. The candidates must be born on or between 1st January, 1982 to 1st January, 2004, date in both ends will be included. Age should be determined as per the matriculation/HSC certificate of the candidate.
- 2. (A) Educational Qualification: The minimum qualification of the candidates should be 10+2 pass or its equivalent qualifications as notified from time to time by CHSE, Odisha with computer proficiency of "O" Level and use of Odia language in computer. Computer proficiency is only qualifying in nature and shall not count for determining the order of merit. The candidates having qualification(s) like, PGDCA, BCA, MCA, B.Tech. (IT), B.Tech. (Computer Science), B.E. (IT), B.E. (Computer Science), Diploma in IT & Computer Science, MSc. (Computer Science) from any Government recognized Organisations/ Universities being higher than "O" Level may also be considered, provided such candidate fulfill all other eligibility criteria prescribed in the extant guidelines.

As regard proficiency in use of Odia language in Computer, a practical test will be conducted at the District level to ascertain the proficiency in use of Odia language in computer.

- (B) Equivalent Qualifications of 10 + 2: For the purpose of equivalency of Higher Secondary (+2), examinations conducted by the institutions declared equivalent by the Council of Higher Secondary Education, Odisha shall be considered. The list of equivalent qualifications of 10 + 2 as provided by CHSE, Odisha vide their Letter No.14527 dt.18.12.2017 is enclosed at Annexure–I for reference and guidance to the candidates. The certificates and the mark sheet furnished by such candidates may be sent to the respective Boards & Universities for verification of the authenticity of the certificates. On receipt of the confirmation on authenticity of the Certificates and the Mark Sheets from the concerned Board/ University, the candidature may be considered provided the candidate must be able to read, write and speak Odia as a language and must have;
- (i) Passed Middle School Examination with Odia as a Language subject; or
- (ii) Passed HSC or equivalent examination with Odia as a medium of examination in non-language subject; or
- (iii) Passed in Odia as a language subject in the final examination of Class- VII from a School or educational Institution recognized by the Government of Odisha or the Central Government; or
- (iv) Passed a Test in Odia in Middle English School Standard conducted by the School & Mass Education Deptt. of the Government of Odisha.
- 3. **Domicile**: The candidate should be a resident of Cuttack District.
- 4. <u>Caste</u>: Candidates belongs to Schedule Caste and Schedule Tribe can only apply against the vacant post of Gram Rozgar Sevak (GRS) under MGNREGS in Cuttack District.

5. CRITERIA FOR SELECTION OF GRS:

Selection will be made as per the automatic generated merit list as per the rules based on the candidates online submitted applications. The selection of candidates shall be strictly on the basis of marks obtained in 10+2 without 4th optional. Marks secured in the fourth optional shall not be included. Provided that in case two or more candidates secure the same marks without 4th optional in +2 or its equivalent examination, the candidate older in age as per date of birth in the HSC Certificate (within the stipulated age limit) will be placed above the younger. Further, if the age of two or more candidates is same, the candidate who has passed HSC Examination on earlier will be placed above the other in the select list. Candidate can view his/her application status in the website by providing the registration number and mobile number till the results are announced.

6. HOW TO APPLY:

Only online application will be accepted from the candidate. Candidates must ensure to go through the notification, instructions and Terms & Conditions thoroughly and understood well before registering himself/ herself for applying online. Candidate who desires to apply online will have to register himself / herself in the portal through https://edistrict.odisha.gov.in with effect from 07.01.2022 to 07.02.2022 with the following basic details to obtain the Registration Number:-

Only one Registration is allowed for one candidate. Mobile number mapping is mandatory for Registration. Once registered the same mobile number will not be allowed for further Registrations of any other candidates also.

- 5. The selected GRS will execute an agreement with the Collector-Cum-CEO, Zilla Parishad, Cuttack within Non-Judicial Stamp Paper and the Collector-Cum- CEO, Zilla Parishad, Cuttack will issue engagement order after execution of agreement.
- 6. Collector-Cum-CEO, Zilla Parishad, Cuttack is the Disciplinary Authority of the GRS and is competent to terminate the contract and disengaged the GRS on the grounds of incompetency, poor performance, negligence in duty, misconduct, violation of orders of higher authorities and violating the terms and condition of engagement.
- 7. If any fraudulent testimonial is detected in future that he/she has been criminally prosecuted, the engagement shall be cancelled without notice and legal action as deemed proper shall be initiated against him/her as per the provision of Law.
- 8. The post of GRS is transferable nature within the Cuttack District. The Collector-Cum-CEO, Zilla Parishad, Cuttack is the competent authority to transfer the GRS from one Grama Panchayat to another Gram Panchayat within the District, in view of exigency of public services or in consideration of genuine grievance or on administrative ground.
