Paradip Port Trust intends to engage 01 (one) Horticulture Consultant on Contractual basis. The details regarding posts showing qualifications, remunerations etc. for the post are as below:

B) Terms & Conditions:

- i) PPT reserves the right either to cancel the circular or increase/decrease the number of engagements without assigning any reason thereof.
- ii) The engagement will be for **01 year** and extendable further based on the performance and requirement of Paradip Port Trust.
- iii) He will monitor and supervise the plantation work carried out by various contractors at Paradip Port Trust and report to Chief Engineer directly.
- iv) The selected candidate will be paid a fixed consolidated monthly remuneration of Rs.35,000/- per month with an enhancement of Rupees @3% per year.
- v) The selected candidate will be provided PPT quarters, subject to availability, on recovery of usual charges as applicable to Port Officers.
- vi) The selected candidate will be posted under the control of the office of Chief Engineer, Paradip Port Trust.
- vii) The selected candidate will directly report to the Chief Engineer, PPT, or any other officer nominated by him, for his daily performance.
- viii)Closed holidays, national holidays, as applicable to Port employees, will be admissible with prior permission of Chief Engineer, PPT. The working days/hours would be at par with Port employees and there is no provision for any extra remuneration if the work is done beyond office hours/holidays.
- ix) The selected candidates will be entitled medical consultation in Paradip Port Trust Hospital for self only. However, no reimbursement for medicine/ medical articles purchased from outside, diagnostic test done outside or treatment received outside will be allowed. This restriction will not apply for treatment of any injury sustained due to accident, occurred in the course of and arising out of the contractual engagement.

- x) The selected candidate shall be responsible for charge and care of the PPT money, goods and stores and all other property that may be entrusted on him/her and he/she will be accountable for the same.
- xi) If the selected candidate is required to go on official tour outside Head Quarters at PPT, he/she will be entitled to TA/DA, as applicable to the similarly placed regular incumbents.
- xii) The selected candidate should not leave headquarters without prior permission of Chief Engineer, PPT.
- xiii)The selected candidate will maintain absolute integrity and devotion to duty and will be liable for penal action for misconduct or causing loss to Port property attributable to her/him during the period of contract engagement.
- xiv) The contractual engagement may be terminated by giving one month's notice from either side. However, the engagement is also terminable on 24 hour's notice for unsatisfactory performance and for any act considered to be derogatory / detrimental to the interest of PPT.
- xv) The engagement is purely on contractual basis and the engagement on contract basis will not confer any right for claiming regular appointment etc.
- xvi) Canvassing in any form will lead to disqualification.
- xvii) No TA/DA is admissible for appearing in written test or interview/personal discussions.
- xviii) The applicant who have already submitted their application for the post of Horticulture Consultant in respect of the advertisement No. AD/RSC-II-21/10 /06(Pt.)/119 dated 13.01.2022 are need not to apply again and the applications received against earlier advertisement No AD/RSC-II-21/ 10/06(Pt.)/119 dated 13.01.2022 will also be considered along with applications to be received against this advertisement.
