2. ELIGIBILITY CRITERIA FOR DIRECT RECRUITMENT OF THE CANDIDATES FOR THE POST OF DRIVER:

A candidate, in order to be eligible for the post shall

- (i) be a citizen of India.
- (ii) have attained the age of twenty one years and must not be above the age of thirty eight years as on **20.04.2022**.

Provided that the upper age limit in respect of reserved categories of candidates referred to in rule 5 of G.A. Department Notification No. 1001, dated 16.01.2014 shall be relaxed in accordance with the provisions of the Act, rules, orders or instructions, for the time being in force, for their respective categories.

- (iii) be able to read, write and speak Odia; and should-
 - (a) have passed Middle School examination with Odia as a language subject; or
 - (b) have passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
 - (c) have passed in Odia as language subject in the final examination of Class-VII from a school or educational institution recognized by Government or the Central Government; or
 - (d) have passed a test in Odia language in Middle English School Standard conducted by the Government in School & Mass Education Department.
- (iv) have passed Higher Secondary School Certificate Examination (10+2) or its equivalent from any recognized School, Board or Institution and have possessed:-

- (a) a valid driving Licence for Light Motor Vehicle;
- (b) knowledge of motor mechanism; and
- (c) experience of driving a motor car for at least three years.

(v) not have more than one spouse living, if married:

Provided that the government may, if satisfied that such marriage is permissible under the personal law applicable to such person or there are other grounds for doing so, exempt any person from the operation of this rule.

(vi) be of good mental condition and bodily health and free from any physical defect likely to interfere with the discharge of his duties in the service. A candidate, who after such medical examination as the Government may prescribe, is not found to satisfy these requirements shall not be appointed to the service.

(vii) not be having any criminal case pending against him/her in the Court of law.

(viii) Every person appointed to the service by direct recruitment shall be on probation for a period of two years and when appointed on promotion shall be on probation for a period of one year from the date of joining the post:

Provided that the Appointing Authority may, if thinks fit, in any case or class of cases, extend the period of probation for one year more:

Provided further that such period of probation shall not include -

- (a) Extraordinary Leave;
- (b) Period of unauthorized absence; or
- (c) any other period held to be not being on actual duty
