

Applications are invited for filling up Gram Rozgar Sevak (GRS) under MGNREGA for Puri District on contractual basis with a consolidated monthly remuneration @ Rs. 7,000/- (Rupees Seven thousand) which may be revised with approval of Government.

Domicile:

The candidate should be a resident of Puri District.

Reservation:

Implementation of provisions of ORV Act can be acted upon on a condition that the post reserved for backward classes if not completely filled-up from among the eligible general candidates as per guideline of the Government in P.R.&D.W. Deptt. vide Letter No. 13276 Dt. 17.07.2018.

Special category-Persons with Disability:

As per Resolution No.1843/SSPED dt.25.02.2021 candidates, who will applied under PWD category candidates must posses valid disability certificate having permanent disability not less than 40%.

As per the views of SS&EPD Department , pursuant to Section 34 (1) & 34 (2) of the Rights of Persons with Disabilities Act,2016 read with Para-18 of the Social Security & Empowerment of Persons with Disability Department Resolution No.7140 dated 5th September,2017, there will be reservation in the post GRS for PwDs with following two categories of benchmark disabilities under clauses (b) & (c) of Section 34 (1) of the Rights of Persons with Disabilities Act, 2016 namely-

(b) deaf and hard of hearing.

(c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy.

Reservation will be 4% of the total number of vacancies proposed to be filed up. Out of which, two percent each shall be reserved for the persons with the above two benchmark disabilities.

Age:

A candidate must have attended the age of 18 years and must not be above the age of 40 years on the 01/02/2023. Age should be determined as per the matriculation/HSC Certificate of the candidate.

How to apply:

- Candidates must go through the details of the advertisement available in the District website i.e. www.puri.nic.in
- The candidate should send their application through Regd.post/speed post only to the **CDO-Cum-EO, Zilla Parishad, Puri At/Po/Dist- Puri, PIN- 752001 by super scribing on the Envelope as "APPLICATION FOR THE POST OF GRS"** within the deadline along with all required documents as per the advertisement uploaded in the website. The candidates are advised to go through the terms & conditions, scrutiny, verification & engagement details before applying for the position.

Terms & Conditions:

- Applications received incomplete, in any other format or by any other means shall be outrightly rejected.
- All posts are contractual in nature and the engagement is initially for a period of one year which can be extended depending upon the requirement and satisfactory performance.
- The selection of candidates shall be strictly on the basis of marks obtained in 10+2. Mark secured in the 4th optional shall not be included. In case, two or more candidates secure the same marks in the examination, the candidate older in age as per date of birth in the HSC certificate (within the stipulated age limit) will be placed above the younger. If the

age of two or more candidates is same, the candidate who has passed HSC examination earlier will be placed above the other in the select list.

- The candidates will be engaged in any Gram Panchayat of the District by the Collector-cum-CEO, Zilla Parishad.
- An undertaking should be submitted by the selected GRS as per the prescribed format given by P.R.&D.W. Department vide letter No. 6681 dated 06.04.18.
- The selected GRS will execute an agreement with Collector-cum-CEO, Zilla Parishad with in non-judicial stamp paper and the Collector-cum-CEO, Zilla Parishad issue engagement order after execution of agreement.
- Collector-cum-CEO, Zilla Parishad is the disciplinary authority of the GRS and is competent to terminate the contract and disengage the GRS on the grounds of violating the terms & conditions of engagement.
- If any fraudulent testimonial is detected in future of if he/she has been criminally prosecuted, the engagement shall be cancelled without notice and action as deemed proper will be taken against him/her as per the provision of Law.
- The post of GRS is transferable in nature within the District. The Collector-cum-CEO, Zilla Parishad is the competent authority to transfer the GRS from one Gram Panchayat to another Gram Panchayat within the District in view of exigency of public service or in consideration of genuine grievance or on administrative ground.
- The list of application rejected along with reasons of rejection will be web-hosted in www.puri.nic.in
- The last date of filling objection will be given at the time of publication of scrutiny list of candidates.
- The list of provisionally selected candidates & final merit list will be published in the district website www.puri.nic.in
- The Collector-cum-CEO, Zilla Parishad reserves all rights to reject or accept any or all application(s) without assigning any reason thereof.
- Authority shall not be responsible for any postal delay.

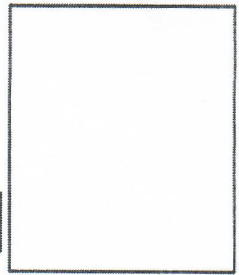
