The ICAR-Central Institute of Freshwater Aquaculture, Bhubaneswar is having a full time dispensary located in its campus in Kausalyaganga. The Director, ICAR-CIFA, Bhubaneswar calls candidates below the age of 70 years in good health having MBBS degree recognized by the Medical Council of India (preference will be given to those having P. G. qualification) to be engaged as Full-Time Medical Officer on contractual basis for ICAR-CIFA, Dispensary.

A Walk-in-Interview will be conducted as per the details given hereunder. The selected candidate will be paid a consolidated amount of Rs.60,000/- (Rupees Sixty thousand) only per month. Accommodation inside the campus may be provided on request on payment of normal license fee and electricity / water charges. The present timing of the dispensary is from 9.00 A.M to 1.00 P.M and 1.30 P. M. to 5.30 P.M. on all working days except on holidays and all Saturdays & Sundays. However, in special / emergencies and as per situation demands, he/ she has to attend the dispensary / patients.

He /She will be entitled to 20 days paid leave in a year and if he/she avails more leave beyond the 20 days, proportionate deduction will be made from the consolidated monthly remuneration.

The tenure of the contract will be for an initially for a period of one year from the date of joining and on expiry of the said period the engagement would be automatically terminated. This will be extendable for a further period of one year on mutually agreed terms & conditions provided the services are satisfactory performance of the Medical Officer and her/his willingness to continue at same rates of remuneration and terms & conditions. The competent authority at ICAR-CIFA, Bhubaneswar reserves the right to terminate the engagement at any time with or without giving notice. In case the candidate desires to leave before the stipulated terms of contract, one month's notice may be served, failing which one month's remuneration will be deducted in lieu of the notice period within the contract.
