1. Walk-in-interview will be conducted for contractual engagement of manpower services (SRF and YPs) for NABL laboratory at CIF, OUAT, Bhubaneswar on **04.10.2025 at 11:00 am**. The details are as below:

2. Eligibility Criteria

Senior Research Fellow (SRF)

- A minimum second-class Bachelor's degree in Agriculture Science /Chemistry/ Biochemistry /Environmental Science/Engineering with at least 55% marks.
- A Master's degree in Agrochemicals/Agriculture Chemistry /Entomology/ Chemistry/ Biochemistry/ Environmental Science/ Engineering with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the concerned subjects from a recognized university or institution.

3. Posting Locations

The manpower services (SRF and YPs) will be required at NABL Lab of the University i.e., Central Instrumentation Facility (CIF) of OUAT, Bhubaneswar.

4. Nature of Job:

- The selected candidates will operate and manage various scientific instruments in the NABL labs at CIF, OUAT, Bhubaneswar.

5. Interview Requirements

- Candidates meeting the eligibility criteria should attend the walk-in interview with all required documents, including a completed application form (**Annexure-1**), self-attested copies of certificates, original certificates for verification, and age proof with a passport size photograph and experience certificate (if any).
- The candidate must also bring all the original certificates from matriculation onwards and experience certificate (if any) with them, without which the candidate will not be allowed for appearing the interview.
- No TA/DA will be provided for attending the interview.
- Employed candidates must bring a No Objection Certificate from their current employer.
- A written test may be conducted if more than six candidates apply for a single post.

6. Selection Process

- Final selection will be based on the candidate's career, experience, performance in the interview, and results from the written examination (if conducted).
- In case of a written test, the top four candidates (based on the test score) will be shortlisted for the interview for each position.

7. Terms and Conditions of Engagement

- The contract period is initially for one year, extendable based on performance and project requirements with due approval from the competent authority subject to availability of fund.
- The engagement may be terminated without notice or explanation if performance is unsatisfactory or disciplinary issues arise.
- The engagement will not entitle to any claim for regular service or any service benefit under the University for which an undertaking in non-judiciary stamped paper has to be submitted.
- Selected candidates must join within 15 days of receiving the engagement order. Failure to do so will result in automatic cancellation.
- A medical fitness certificate from a physician must be submitted before joining.
- The performance of the manpower services (SRF and YPs) will be reviewed every month by the PI/Co-PIs of the NABL Lab, OUAT and the engagement may be terminated at any time without any notice, if the performance of the manpower services (SRF and YPs) is found unsatisfactory, failure to maintain discipline/ laboratory protocols.
- In case the manpower services (SRF and YPs) intend to leave the engagement before completion of the tenure, then he/she has to inform the PI, NABL lab, OUAT one month prior to leaving.
- In addition to all the above terms and conditions, the authority may prescribe some more conditions from time to time and all these will be binding on the analyst.

N.B. The date and time of the walk-in interview may be changed under administrative exigencies and any change will be notified on the website. So, the interested candidates are required to check the website (www.ouat.ac.in) for such updates.
